AUTHORIZATION TO CALL ELECTION BY THE CHIEF EXECUTIVE OF THE NON-REMOVABLE MILLE LACS BAND OF OJIBWE INDIANS

WRIT OF ELECTION

WHEREAS, On January 20, 2012, the Tribal Executive Committee of the Minnesota Chippewa Tribe announced an election, pursuant to Article IV, Section 1 of the Minnesota Chippewa Tribe Constitution, for the purpose of electing by popular vote the Chief Executive and the District I Committeepersons (Representatives of the Band Assembly, District I) on the Mille Lacs Reservation, with the Primary Election being held on April 3, 2012 and the Regular Election on June 12, 2012.

WHEREAS, On January 25, 2012, a Joint Session of the Band Assembly authorized a Primary Election on April 3, 2012, and a Regular Election on June 12, 2012, for the purpose of electing by popular vote a Chief Executive, a District I Representative, and a Nay-Ah-Shing School Board Chairperson and a District I and District II Nay-Ah-Shing School Board Member.

NOW THEREFORE, I, Marge Anderson, Chief Executive of the Non Removable Mille Lacs Band of Chippewa Indians, under and by virtue of the Minnesota Chippewa Tribe Constitution and Mille Lacs Band Statutes Title 3 § 26, hereby issue this Writ of Election for a Primary Election to be held on April 3, 2012 and the Regular Election on June 12, 2012.

The elected Positions are as follows:

1. Chief Executive, for a four year term.
2. District I Representative, for a four year term.
3. Chairperson, Nay-Ah-Shing School Board, for a four year term.
4. District I Nay-Ah-Shing School Board Member, for a four year term.
5. District II Nay-Ah-Shing School Board Member, for a four year term.

Candidates for elected office shall file with the Secretary/Treasurer, or his designee during regular Band Government business hours beginning on January 23, 2012 and ending on February 3, 2012 at 4:30 p.m.
