Status Report – July 2023

On May 12, 2021, the Non-Removable Mille Lacs Band of Ojibwe Band Assembly (“Band Assembly”) approved Legislative Order 33-21, which adopted Rules of Procedures for Band Assembly. Pursuant to Rule 10.2 of the Rules, the Revisor of Statutes must prepare and publish a monthly Status Report during regular session of Band Assembly. Such Status Report must list all measures under consideration (including their titles and sponsors) and a history of action taken.
