POLICY STATEMENT: Mille Lacs Band of Ojibwe Four Winds Lodge will consider admission of Level 1 and Level 2 Predatory Offenders on a case-by-case basis.

PURPOSE: The purpose of this policy is to ensure the safety of all clients, their families and staff.

DEFINITIONS:

<u>Predatory Offender:</u> Person who is required to register as a predatory offender under MN Statutes, section 243.166, for offenses listed in that statute, as well as, for circumstances and offenses listed in MN Statutes, section 243.167

Risk Level: PER Bureau of Criminal Apprehension (BCA)

- Risk levels are assigned by the MN Department of Corrections (DOC) not the Bureau of Criminal Apprehension.
- Risk levels are assigned to registrants who are released from prison on or after January 1, 1997.
- Risk level one indicates the least likelihood to re-offend. Risk level two indicates a moderate likelihood to re-offend. Risk level three indicates a high likelihood to re-offend.
- Information about level 3 offenders is available on the DOC web site.

PROCEDURE:

- Upon referral, admission staff will contact client's probation/parole agent and request a FACT sheet as well
 as restrictions.
- Treatment Director, Clinical Supervisor and RN Supervisor will meet to review all information gathered on client and determine if client is appropriate for Four Winds Lodge level of care.
- Admission staff will contact referral and inform them of decision. If accepted they will follow the Admission Criteria/Service Initiation Policy.
- Immediately upon admission client will sign a release of information to the Brainerd Police Department as well as probation/parole agent to allow for the sharing of information, should client choose not to sign the release, the admission will be stopped and the client will not be allowed into treatment.

- The offender registration should be completed prior to arrival at Four Winds Lodge. If it has not been completed, have the client's transportation people take to client to Brainerd Police Department to complete the registration. If transport is not able, Four Winds Lodge will transport them.
- Upon discharge:
 - LADC/UMICAD and aftercare coordinator will contact referent and PO prior to discharge and discuss discharge placement.
 - LADC/UMICAD will then follow Discharge/Aftercare Policy.
