Work Scope:

Provide all labor and materials for the performance of all special inspections and testing per specifications as identified on the bid form. Construction activities are anticipated to include Aggregates for subbase, Bituminous Mixtures, and Concrete Mixtures along with trip charges. Submitted unit pricing costs shall be used to calculate services used under this allowance. Unused allowance will be credited back to the Owner. Billing shall be based on itemized testing and inspections completed monthly.

Bidding Notes:

Your proposals shall include the following:

1. Bid should show a fixed fee to do the above mentioned work schedule. Bid ***must be signed*** by contractor to be valid.
2. Copy of current MLB Vendor's License. (or a copy of submitted application)
3. Copy of current certificate of insurance for General Liability and Property Damage.
